Step 1. Do you meet the requirements?

- Be at least 16 years old the day your program begins, but not yet 21 by its conclusion.
- Be strong and robust (Northern Tier height and weight requirements listed in this application will be strictly followed.)
- Be a registered member of both the BSA and an OA lodge.
- HAVE A VALID PASSPORT.
- SUBMIT REMOTE AREA BORDER CROSSING PERMIT APPLICATION (included with this application) WITH SUPPORTING DOCUMENTS TO NORTHERN TIER NATIONAL HIGH ADVENTURE PROGRAMS NO LATER THAN APRIL 15.
- Have a clean criminal record (this is required to cross the international border).

Step 2. Complete and submit the application.

- Complete the enclosed application.
- Mail your completed application (available online in a fillable PDF) and \$50.00 deposit to the:

Step 3. Preparing for your trip.

- Participant cost is \$200 for the two-week experience. A \$50.00 non-refundable deposit is required with the application

Medical

 All Participants must have a current BSA Health and Medical Record.

The following table shows the recommended weights for each height, as well as the maximum weight for that height. Northern Tier strongly recommends that each participant not exceed the maximum weight on the table for their height. Northern Tier requires that you fall below the maximum (295 pounds) allowed weight for participation. Additionally, Northern Tier strongly recommends that no participant weigh less than 100 pounds. Smaller participants will have a very difficult time due to the strenuous nature of the trek and the heavy weight of items to portage.
